Fees are calculated by the Fire Division on each individual permit form. The total fee due shall be paid at the time of submittal. No plan review or site inspections will be started without full payment of fees. Additional fees may be billed if the actual time exceeds the minimum amount of the deposited amount. Additional Building Permits may be required for this project. The applicant is responsible for contacting the Building Department to determine if any additional permits or approval is required.

I certify that I have read this application and that all the above information is correct. I agree that I am solely responsible for complying with and that I will comply with all City Ordinances and requirements and State laws relating to Building and Fire codes.

This Permit does not constitute an approval or waiver of any violation of the recited provisions, nor of any State law or City Ordinance, regulation or requirement.
