The maintenance inspection on the South and North Courses occurred on April 11th, 2024

### **SOUTH COURSE**

#### 1. GENERAL OBSERVATIONS:

Overall the South course is in good condition. The greens and fairways look really good. The gophers seem to have been reduced since the last inspection, this is great news. The ruff areas had a lot of thatch, which is understandable for this time of year. There was some storm debris still left over such as fallen trees, brush piles, logs and sediment throughout the course. This is not concerning seeing as the soil is still too wet to get equipment out there to remove the debris. I would expect this to be cleaned up by the summer inspection. The weather was beautiful the day of the inspection and it was a pleasure performing the inspection and the course was enjoyable to be on.

Rating: Fair

## **Cart Paths**

Cart paths (concrete infrastructure) are in fair condition. They need to be edged and blown off. I noticed a lot of thatch on all cart paths. This is inevitable when mowing, but if they were blown off after, it would really make the course pop. I also noticed a lot of ruts from carts along the pathways. Some were really deep and spilling out on to the path, creating a slipping hazard.

Rating: Fair

#### **Fairways**

Fairways are in good condition. They were free of gopher mounds and weeds for the most part. I did notice most of the trees throughout the course had suckers or weeds around the tree wells. The north course does not have this issue. I would like to see that improve.

Rating: good

#### Greens

The greens are firm and appropriately cut.

Rating: Good

#### **Bunkers**

The bunkers are in good shape considering the drainage issues they have. They were raked out, edged, and overall looked very nice.

Rating: good

#### **Out-of-Play Areas**

The out of play area is in fair condition. I noted in the winter inspection of seeing weeds and suckers in the tree wells. This continues to be an issue in the spring. I noticed they were mowed, but had a lot of thatch left behind. The fence lines were shaggy and had some tall grass along them. I also noticed that there was a lot of standing water in these areas, so I'm sure mowing and even weed whacking can be challenging. Overall these areas looked better than the last inspection.

Rating: Fair

## Maintenance Credit Area (along Golf Course Dr.)

The Maintenance Credit Area looks much better than the winter inspection. The irrigation repairs that were in the area have since been fixed. I noticed a lot less gophers and dead spots in the turf. I did however notice the edge along Golf Course Dr needs to be kept up better. There was grass and weeds overgrown, to the point that it was hitting the gutter. And as stated in other areas, the tree wells need to be free of suckers and weeds. Overall, I give this are a fair rating.

Rating: fair

#### **Pro Shop**

The Pro Shop looks really good. When I walked in I was greeted by friendly staff that asked if I needed any help or had any questions. The layout of merchandise was awesome.

#### **AREAS IN NEED OF IMPROVEMENT (noted in previous report):**

- The gopher issue needs to be addressed throughout the whole course
- Tree wells need to be weed whacked or sprayed
- The out of play areas need to be worked on. Trim back blackberry bushes and other shrubs, tree wells, suckers...

#### RECENT IMPROVEMENTS

• Gophers have been addressed.

#### **AREAS IN NEED OF IMPROVEMENT (Spring 2024):**

- Cart paths need to be edged and blown off
- Remove suckers and weeds in tree wells
- Storm debris removed and cleaned up
- MCA edged
- Ruts along cart paths filled or fixed

#### **NORTH COURSE**

#### 1. GENERAL OBSERVATIONS:

The overall appearance for the North Course is really good. It is evident that a lot of work has gone into making the North Course look the way it does.

Overall Rating :very good

#### **Cart Paths**

Cart paths looked good. They needed to be edged but overall they were clear of debris and mud

Rating: good

#### **Fairways**

The fairways look amazing as always

Rating: very good

## **Greens**

The greens look amazing

Rating: Very Good

#### **Bunkers**

Bunkers look awesome. The sand is still white and free of weeds or debris.

Rating: Very good

#### **Out-of-Play Areas**

The natural habitat areas look good. There is a defined line that separates the turf from the natural habitat. I noticed the sand is still there from the old bunkers. Are there plans for that? The pile is collecting weeds and it would be nice to remove the pile or reuse the sand in areas of the course.

Rating: Good

#### 2. AREAS IN NEED OF IMPROVEMENT (noted in previous report):

Sand in out-of-play area

#### 3. RECENT IMPROVEMENTS:

The renovated bunkers seem to really be holding up well.
